

Early Booking Breeding Contract – First 10 contracts received and paid in full by January 15, 2025 2025 FROZEN SEMEN BREEDING AGREEMENT

("Stallion") owned by Adh I	Mor Ranch ("	Breeder"). The 2025 breeding season, which begins February 1,		
2025 and ends June 30, 2025, subject to the following terms and conditions:				

- 1. This contract is to be returned with a full non-refundable \$2300 US booking fee. This fee is made payable to Frozen Partners.
- 2. Please email this completed contract to info@frozen-partners.de
- 3. A copy of the Mare's registration papers must accompany this contract when sent to Frozen Partners.
- 4. This original frozen breeding contract allows for the use of a maximum of three (3) frozen breeding doses. One (1) frozen breeding dose will be released at a time and authorized by Frozen Partners. If the maximum allowed number of frozen breeding doses are used before the result of a live foal, the Mare Owner will be subject to a \$500 US fee for any additional doses requested until a live foal is born.
- 5. Each dose of frozen semen includes eight (8) 0.5ml straws containing a minimum of 600 million progressive motile sperm with a post thaw motility of no less than 30%. The Mare Owner agrees to use the entire eight (8) straws of semen on a single breeding cycle.
- 6. **Shipping Expenses**: Are the responsibility of the Mare Owner to pay. Authorization and arrangements for frozen semen release is to be communicated with Frozen Partners.
- 7. **Embryo Transfers:** If more than one (1) embryo is produced from the Mare's breeding to the Stallion and is transferred, the Mare Owner must notify the Agent upon heartbeat confirmation. The Mare Owner will be responsible to pay an additional stallion fee of \$2500 US to the Agent prior to issuance of any breeder's certificates. If one or both of the pregnancies fail and do not yield a foal that encompasses the LFG, the Mare Owner will be allowed a rebreed in the subsequent breeding year only and subject to a \$500 US rebreed fee.
- 8. <u>Live Foal Guarantee (LFG):</u> This contract contains an LFG for when the Mare has a pregnancy checked and declared to be safe in foal by a veterinarian. A live foal is described as a newborn foal that stands and nurses without assistance within the first 24 hours following birth. Additionally, if the Mare miscarries, aborts or the foal is born dead, the Mare Owner must notify the Agent within ten (10) days with a written statement by a veterinarian of the occurrence. If no notification is made, the Mare Owner will forfeit any opportunity to rebreed within this breeding contract privilege.

- 9. **Rebreed:** If the Mare is reported open at the end of this breeding season, the Mare Owner will be allowed the opportunity to rebreed in the subsequent breeding season only. A rebreed fee of \$500 US will be due at the time of signing.
- 10. Mare Substitutions: If the original designated Mare to this breeding contract is deemed unfit to breed or dies, the opportunity to substitute another mare will be allowed at no additional cost. The opportunity to do multiple mare substitutions within one breeding contract is limited and has to be approved by the Agent prior to any semen being used on the substitute mare. A revised contract noting the substitution must be executed prior to any breeding of the substitute mare. If it is determined that a Mare Owner has used any other mare than the Mare designated in the original contract without authorization, a \$2000 US penalty will be applied and no issuance of a breeder's certificate.
- 11. **Reporting Mare Pregnancy Status:** The Mare Owner is responsible to report the pregnancy status, including if the Mare is open to the Agent no later than August 15, 2025. Failing to report to the Agent will forfeit any opportunity to rebreed if the Mare is open. A \$100 US late filing fee will be due if the Mare is reported pregnant after the August 15Th cutoff.
- 12. <u>Breeder's Certificate Release:</u> The Breeder will release the breeding certificate once a live foal has been reported and all fees are paid in full. Please notify the Breeder via email amandak0580@yahoo.ca The Breeder's Certificate will be released to the recorded Owner of the Mare at the time of the breeding. If the Mare is sold in foal, the involved parties will have to inform the Breeder of such transaction prior to a Breeder's Certificate release.
- 13. Transfer of breeding contract: This breeding contract is entered and executed by the original signed parties only. There will be NO TRANSFERRING OF THIS CONTRACT NOR SOLD TO ANY OTHER MARE OWNER OR ENTITY. Any frozen semen used outside of this breeding contract and/or without any communication to the Agent WILL BE PENALIZED \$2000 US PER BREEDING ATTEMPT.
