



BREEDING CONTRACT

I hereby agree on the _____ day of _____ 20____ to breed the mare,
_____ registration number _____, to the stallion
COLONELS DANCING GUN AQHA#5589947 for the 20____ breeding season.

The stallion fee is € 1800 (€ 1500 if booked before 31st Jan 20____) which includes a € 500 non-refundable booking fee which is payable upon execution of the contract. The remainder of the stallion fee is due prior to the first semen shipment or the first insemination. If the breeding is not paid in full, semen will not be sent. All monies except shipping charges from the European storage station to the individual breeder are to be sent to Frozen Partners. A photo static copy of the registration papers on your mare must accompany this contract. The owner recorded on the registration papers will be the owner recorded on the stallion breeding report.

The breeding fee allows up to two (2) doses of frozen semen to be allocated to a mare in one breeding season. If the mare fails to conceive with the two doses, additional shipments may be authorised. Shipping and importation fees will apply for each additional shipment (€ 250 per dose + shipping).

This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is born dead, or a mare absorbs/aborts a predetermined pregnancy there are return privileges only if the Stallion Owner or Frozen Partners is notified within thirty (30) days and receives a statement confirming this. A "Live Foal Guarantee" will apply only to those mares that are certified in foal by a licensed, attending veterinarian. Confirmation of such pregnancy in the form of documented ultrasound picture or letter from the attending veterinarian must be received by October 1 of the breeding year.

If the mare absorbs or aborts a pregnancy after having been checked in foal, or if the mare fails to conceive during normal breeding season, the Mare Owner is entitled to a rebreed for the following season only. The Stallion Owner may require the rebreeding to be performed at a breeding station approved by the Stallion Owner and the Mare Owner agrees to pay mare care and other normal expenses relative to the breeding. There is a charge of € 350 for rebreed service expenses plus any additional shipping fees. A substitute mare, accepted by the Stallion Owner may be used if the original mare is deceased or deemed unfit for breeding by a licensed attending veterinarian. A substitution fee of € 100 will apply. The stallion owner reserves the right to require a substitution if the mare fails to settle or is deemed unfit for breeding.

A Breeders Certificate will be issued for the foal conceived as a result of the breeding. The Breeders Certificate will be issued only after all expenses have been paid in full and after the foal is born and reported to Frozen Partners. Neither the Stallion Owner nor any of its officers or employees shall be liable for damages as a result of damage to the semen or as a result of a mare failing to settle.

In the event that the stallion dies, is unavailable, or becomes unfit for service, this Agreement will immediately terminate. The Stallion Owner shall have no liability to Mare Owner except notification of its occurrence. Refunds of Stallion Fees (less booking fee) will be given at the sole discretion of the Stallion Owner. In the event that the mare dies during the breeding season, the Mare Owner may substitute another mare as may be agreed upon by both the Mare Owner and the Stallion Owner.

When signed by both parties this document will become a legally enforceable contract binding both parties. An equine professional is not liable for an injury or death of a participant in equine activities resulting from the inherent risk of equine activities.
