ICSI Contract:

The stallion fee is \$11,000 which includes a \$3000 non-refundable booking fee which is payable upon execution of the contract. The remainder of the stud fee is due at the birth of a live foal.

ICSI will be performed at a facility approved by McQuay Stables. Any additional embryos produced by ICSI will incur an additional \$11,000 stallion fee. \$3000 at 30-day pregnancy and \$8000 at the birth of a live foal. Additional embryos may be frozen - but must be reported to McQuay Stables at the time of freezing, and again at time of implantation in a recipient mare. \$3,000 will be due when the mare checks 30 days in foal and the additional \$8000 at the birth of a live foal.

Semen is available at most of the major ICSI labs in the US and Europe. The Mare Owner is responsible for checking with McQuay Stables to verify the lab and that the lab has semen stored. If it is a new lab and McQuay Stables approves it, semen will be sent and the Mare Owner will pay for the shipping. McQuay Stables makes no representation or warranties, expressed or implied, regarding quality and characteristics of the frozen semen delivered under this agreement, and shall not be responsible for delayed, lost, or mishandled deliveries.

Terms and Conditions

A photo static copy of the registration papers on your mare must accompany this contract. The owner on file with AQHA at the time of breeding will be the owner recorded on the stallion breeding report.

A substitute mare, accepted by the McQuay Stables, Inc. may be used if the original mare is deceased or deemed unfit for breeding by a licensed attending veterinarian. A substitution fee of **\$100** will apply. McQuay Stables, Inc. reserves the right to require a substitution if the mare fails to settle or is deemed unfit for breeding.

A Breeders Certificate will be issued for the foal conceived as a result of the breeding. **The Breeders Certificate will be issued only after the stud fee and all expenses (including veterinary and recipient mare expenses) have been paid in full and after the foal is born and reported to McQuay Stables, Inc.**

It is the mare owner's responsibility to report embryos working and foals born to McQuay Stables in a timely manner. Pregnancies reported later than 11/1/2026 will incur a late add fee of \$200. Foals not reported by December 31st of their birth year will incur a late fee of \$2500. Foals reported after their yearling year will incur a late fee of \$5000. Reports are to be made by EMAIL ONLY to mcquaystables@gmail.com.

When signed, by both parties, this document will become a legally enforceable contract binding both parties. The parties acknowledge that this agreement is made and shall be considered to be entirely performed within the State of Texas and shall be construed and enforced under the laws of the State of Texas Law (Chapter 87, civil practice and remedies code), an equine professional is not liable for an injury or death of a participant in equine activities resulting from the inherent risk of equine activities.

This Agreement may be executed in one or more counterparts, each of which shall be deemed an original document, and all of which together shall constitute a single instrument. Facsimile or electronic versions of signatures, including e-signatures, will have the same force and effect as original signatures.
