



2026 BREEDING CONTRACT – FROZEN SEMEN

Promo First 50

This certifies _____, herein referred to as Mare Owner/Agent, has engaged a breeding service to the stallion **GUNNER DUN IT AGAIN**, AQHA #5374581 APHA #1,006,155 for the mare _____, Registration # _____, for the 2026 breeding season.

The Mare Owner/Agent agrees to pay a breeding fee of **\$2,200** (listed below all details):

- **PROMO FIRST 50 (*)** \$ 1,550 (protocol# _____/50)
- **Chute fee** \$ 650 **NON-REFUNDABLE (payable upon execution of this contract)**

(*) This special breeding fee for early booking MUST BE PAID IN FULL. Only 50 contacts will be sold at the reduced price of \$2,200, first come first served. No further discounts for earner or producer mares will be applied.

Any deviation from these terms must be specified in writing and signed by TRIPOL RANCH LLC authorized representative. **The balance of the entire breeding fee is due prior to first shipment of semen**, no exceptions. The following conditions of service (for which there will be no exceptions) are mutually agreed between the Mare Owner/Agent, named above, and TRIPOL RANCH LLC, as owner of the above Stallion, upon the execution of this contract:

Pre-Breeding Arrangements (please provide each item listed below):

- A photocopy of your mares registration papers
- Payment of stallion and chute fees and/or Rebreed fees
- Credit card authorization form for remaining fees and/or shipping fees
- **PLEASE INCLUDE MY AQHA MARE ON THE APHA STALLION REPORT (*)**: YES NO
() As GUNNER DUN IT AGAIN is double registered, all Quarter Horse mares will be listed on the AQHA Stallion Report, and will be given the option to be included on the APHA Stallion Report. Should you wish to opt out of the double registry option, please circle no. Otherwise please circle yes. This does not apply to registered APHA mares.*
- The breeding is NOT considered SOLD unless the total breeding fee has been paid.
- Any incomplete registration certification or unpaid charges will result in a hold being placed on the mare's name on the appropriate stallion breeding report.
- Unless shipping has been prepaid in conjunction with the contract, it WILL NOT be shipped without a current credit card authorization form on file. Credit card payments are subject to a 4% processing fee.
- This contract is valid for the 2026 breeding season only.
- Every effort will be made to accommodate Mare Owner/Agent's breeding time frame. However, it is the Mare Owner/Agent's responsibility to ensure that TRIPOL RANCH LLC has up to date information at all times throughout the process. In doing so, you are facilitating the insemination process. Failure to adhere to these arrangements may result in missed heats and delayed shipments (where applicable) at the Mare Owner/Agent's expense. A veterinarian knowledgeable in successful insemination techniques must oversee off site inseminations in order to maximize the potential of a timely pregnancy.
- This contract covers the purchase of GUNNER DUN IT AGAIN frozen semen. Each dose will contain the correct amount of straws required for one insemination plus a rebreed.
- All semen remains the property of TRIPOL RANCH LLC. **Selling of any unused semen is forbidden**, the customer agrees to pay TRIPOL RANCH LLC an additional stud fee for every used or unused straw not returned to GUNNER DUN IT AGAIN within the timelines laid out in this agreement.
- No frozen semen will be shipped until all fees are paid in full. The mare owner will need to arrange for liquid nitrogen storage for the frozen semen when it arrives. Mare owner must transfer the semen immediately from the Dry Shipper into a Liquid Nitrogen Storage Tank. Failure to transfer the semen within 24 hours of receipt will void this contract and may have jeopardized the integrity and quality of the frozen semen.
- Frozen semen will be shipped in a Liquid Nitrogen "Dry Shipper" at the Buyers shipping expense
- The shipment should be planned at a minimum of 2 weeks prior to when the buyer plans to breed their mare to ensure the semen is available when required.
- TRIPOL RANCH LLC is not responsible for the frozen semen once it has been shipped. Insurance is required on each shipment for the container (\$1,000) and the frozen semen with Federal Express. Once the semen arrives, it should be checked & transferred to storage promptly. The shipment is sealed with a plastic tie wrap. The Buyer should ensure that this tie wrap has not been broken and that the Dry Shipper is frosty when first opened. Frozen semen should not be held out of the tank for more than 8 seconds or the semen will be damaged. If the shipment did not arrive sealed and cold, a claim should be made by the Buyer to Federal Express and TRIPOL RANCH LLC promptly within 24 hours or insurance is not valid. It is the responsibility of the Buyer to file this report. TRIPOL RANCH LLC is not responsible for frozen semen that has been mishandled.
- The buyer will receive 2 breeding doses of GUNNER DUN IT AGAIN frozen semen in the first shipment for use over 2 separate breeding cycles.
- **The splitting of doses or straws is strictly forbidden.**
- In case of embryo transfer or ICSI (intracytoplasmic sperm injection), the mare owner must inform TRIPOL RANCH LLC immediately. By signing this contract mare owner agrees to pay an additional fee equal to the original breeding fee for each live foal from the semen provided. If mare owner decides to freeze embryos, a breeding fee is due for each frozen embryo.





- The price paid for this contract is for a single foal. **Additional foals obtained from the semen is required to pay additional stud fees for each additional foal.**
- If all additional pregnancies are not reported timely, Mare owner will be subject to a \$20,000.00 penalty breeding fee for all additional pregnancies prior to TRIPOL RANCH LLC a breeder's certificate for any of the resulting foals.
- All embryos frozen pursuant to this contract to be used at a later date must be reported to TRIPOL RANCH LLC in the year frozen. **Mare owner will be required to pay the breeding fee in effect at the time the frozen embryos result in a confirmed pregnancy.**
- If all additional pregnancies resulting either from an embryo transfer or frozen embryo implantation are not reported and paid for timely (as specified above), Mare owner will be subject to a \$20,000 breeding fee for all additional pregnancies prior to TRIPOL RANCH LLC issuing a breeder's certificate for any of the resulting foals.
- If the mare is bred using a partial dose (e.g. deep horn method using less than the full dose provided) and becomes pregnant, **all remaining straws must be returned to TRIPOL RANCH LLC.** If the mare owner would like to keep the straws, they can be purchased paying an additional breeding fee.
- If the mare becomes pregnant with 1 breeding dose, the mare owner must arrange to return the extra dose or purchase an additional breeding contract.
- The mare must be inseminated using one full dose of frozen semen within 4-6 hours post ovulation. Do not breed using frozen semen if the veterinarian/mare owner suspect the mare has ovulated more than 6 hours earlier. Post ovulation ensures that the mare owner will not require more than 1 dose per heat cycle.
- If all conditions detailed in this contract have been met and there isn't a confirmed pregnancy after the second breeding cycle the mare owner can request a second and final shipment of 2 doses.
- A mare may be substituted only with a veterinarian's letter stating the mare is unbreedable and/or the approval of TRIPOL RANCH LLC.
- If a mare dies, or is deemed unfit to breed, during the breeding season (a veterinarian report will be required as verification) a substitute mare, owned by the same Owner and approved by the TRIPOL RANCH LLC, may be bred without any additional breeding fee. Substitutions and/or switching of mares owned by the same owner for any other reason **will be subject to a \$200 transfer fee.** Transfers of fully paid breeding contracts, to an owner other than the person stated on the contract, **will be subject to a \$200 transfer fee.**
- Confirmation of pregnancy by ultrasound starting at 14 days post ovulation continuing through to the 45th day of pregnancy is **REQUIRED TO MAINTAIN THE LIVE FOAL GUARANTEE.** If ultrasound is unavailable, Mare Owner/Agent agrees to have the mare checked for pregnancy by licensed veterinarian within 30 days of insemination. Mare Owner/Agent agrees to provide the results of the ultrasound(s)/pregnancy exam(s) to TRIPOL RANCH LLC no later than 30 days following insemination.
- **LIVE FOAL GUARANTEE.** A live foal is defined as one that will stand and nurse. If foal is born dead, Mare Owner/Agent agrees to furnish a veterinarian's certificate describing the occurrence to TRIPOL RANCH LLC within 7 days. In such a case return privileges will be available for one year only. Re-breeds must pay the fee applicable for the re-breed year and any relevant shipping charges. If the mare aborts or fails to conceive, she may return during the current breeding season. If TRIPOL RANCH LLC deems it too late in the season to re-breed a mare during the current season, TRIPOL RANCH LLC may permit the mare to be re-bred the following year. Re-breeds on the same mare must pay the fee applicable for the re-breed year (**\$650**) and shipping charges; all re-breed fees and all relevant shipping charges **MUST** be paid in advance of re-breed. RE-BREED privileges are valid for **one year only, following the initial contract.** After that time the obligations of the Stallion owner and TRIPOL RANCH LLC are deemed to have been fulfilled and a new contract must be made.
- 5 panel test results: HERDA N/N, PSSM N/N, GBED N/N, HYPP N/N and IMM N/My.
- If Federal Express/UPS delivery is unavailable within a 24 hour period, additional notice will be required. Mare Owner/Agent should check with Federal Express/UPS for weekend delivery, holiday delivery or customer pickup.
- TRIPOL RANCH LLC shall not be responsible for COSTS arising from shipments lost, damaged or delayed in transit. TRIPOL RANCH LLC shall take every reasonable precaution to ensure that the semen is protected during shipment. However, neither TRIPOL RANCH LLC or their staff control the shipment once it leaves their custody and therefore shall not be responsible for the condition of cooled shipped semen received by Mare Owner/Agent.
- Customer must specify shipment method, Federal Express or airline counter-to-counter service, when ordering semen. For counter-to-counter, Mare Owner/Agent must provide the name of the destination airport (the airport to which the shipment is to be sent).
- It is the Mare Owner/Agent's responsibility to return a copy of the INSEMINATION CERTIFICATE, signed by administering Veterinarian or Breeding Facility Manager, to TRIPOL RANCH LLC and to forward a signed copy of the certificate to the appropriate Breed Registry. Mare Owner/Agent is also responsible for blood typing or DNA testing their mare as per AQHA rule #209 or APHA rule RG-165.
- **If a second foal is conceived, with the same mare on this contract or another one, with the same dose of cooled semen shipped or a leftover of frozen semen, a registration application will be provided only after payment of breeding fee at rates currently in effect.**
- **a \$200 late fee will be charged to the breeder if a pregnancy communication is made after the breeding year of the mare**

The undersigned agrees that the breeder and its agents, TRIPOL RANCH LLC and employees will not be responsible for accident, injury, sickness, or death to the mare or its foal; whether from fire, flood, theft, act of god, negligence by the breeder or any of its agents or employees, or for any other reason. The undersigned agrees to and shall indemnify and hold harmless the breeder and its agents, TRIPOL RANCH LLC and employees from and against any and all claims, losses, damages, causes of action, suits and liability of every kind. This includes all expenses of litigation, court costs and attorney's fees, for injury to or death of the mare or its foal arising out or in connection with the services performed by the breeder under this contract, regardless of whether such injuries or death are caused in whole or in part out of negligence of the breeder or its agents or TRIPOL RANCH LLC or employees





When signed, by both parties, this document will become a legally and enforceable contract binding both parties. The parties acknowledge that this agreement is made and shall be considered to be entirely performed within the State of Texas and shall be construed and enforced under the laws of the State of Texas Law (Chapter 87, civil practice and remedies code), an equine professional is not liable for any injury or death of a participant in equine activities resulting from the inherent risk of equine activities. Both parties furthermore agree that the booking/chute fee is NOT REFUNDABLE in any case.
