CONDITIONS

The mare owner purchases for the breeding season 2026:

- Fresh Semen** onsite breeding (mare is transported to Riverside Ranch)
- Cooled Semen (KS)**
- Frozen Semen (Surcharge) 250 €**
- Frozen Semen for ICIS**

Fresh and cooled semen is available from is usually available from mid February to mid July. The stallion is available to AQHA- and APHA-mares. In case of sickness or show-participation the stallion owner reserves the right to provide frozen semen. Show-participation will be published four weeks in advance. A refund of the breeding fee does not apply in both cases

BREEDING FEE

- Regular breeding fee €1,850**, payable before shipping of the semen.
- Early booking breeding fee € 1,550**, valid until 31.01.2026, payable until 31.01.2026
- Repeater €100 Voucher** for Breeders who repeatedly breed TomTom.
- ICIS only € 950** base fee to be paid before the ICSI session takes place, read section ICSI for details

The stallion will be entered in the SSP Program of the NRHA Germany, NRHA Belgium Sire and Dam and the Italian Reining Horse Association for 2026. For previous years a late entry into a program can on no account be requested by a mare owner.



ORDERING AND SHIPPING SEMEN

The breeding fee must be fully credited to the stallion owners bank account before semen can be shipped. The costs for shipping are not included in the breeding fee and are chargeable to the mare owner. These costs are billed by the breeding station are to be paid to the breeding station. Please ask for detailed pricing. For shipments to destinations outside of Germany the laws and conditions of the respective country are valid. The costs for any custom duties and/or any veterinary certificates will be debited to the mare owner by the breeding station. **Shipments of semen is not possible on Saturdays, Sundays and official holidays.** The breeding station must be contacted by phone three days before the required shipping date. Orders for semen should be placed Mondays to Fridays before 10:00 AM German time in order for the semen to be shipped on the same day. The number of portions is limited to two per estrus per shipment. The costs for collection and handling of semen are to be covered by the mare owner and are billed by the breeding station. Please ask for detailed pricing. A list of these fees can be displayed here: <https://www.r-ranch.de/deutsch/zuchtstation/preise/> At the time of writing this contract the costs for shipment of semen within Germany amounts to 40 €. This is subject to change. Other countries on demand.

The number of frozen semen doses is two. Should further doses be required by the mare owner, then a fee of 380€ per two doses is to be paid to the stallion owner. Costs for shipment are to be covered by the mare owner. For frozen semen an additional fee of 250€ is levied. With his/her signature on this contract the mare owner confirms that the mare is healthy, and a swab sample was taken. The semen must be processed immediately by competent personnel. The responsibility for the correct processing lies with mare owner. The stallion owner is to be informed if the mare is in foal and the date of the last insemination until 31. August. Only if this is done by the mare owner the stallion owner is responsible for providing the registration certificate.

REBREEDING

In case of a rebreed of a mare in the following year a fee of 380€ is levied. Is the respective mare not healthy or has died, the breeding can be transferred to a mare acceptable to the stallion owner at a cost of 100€. Costs for collection and shipment of semen are to be covered by the mare owner. In case the stallion is not available e.g. in the case of death, illness, or show-participation the rights for a rebreed are abolished. A partial refund of the breeding fee will be considered by the stallion owner. No compensation can be claimed from the stallion owner.

ICSI

Any additional embryos produced by ICSI will incur an additional stallion fee listed below when checked 45 days in foal. Frozen embryos must be reported to the stallion owner when frozen, and again when placed into a recipient mare. Any organization can be chosen by the breeder for the ICSI process.

Stallion fees are payable when recipient mare is 45 days in foal:

1st embryo	Included in the base fee
2nd embryo	900 Euro
3rd embryo	700 Euro
Any additional embryo, each	500 Euro

IN-FOAL REPORTING

Breeders need to report their mare or mares in foal by October 31st each year. Later reports will incur an administrative fee of 200 Euro plus the applicable fee levied by the American Quarter Horse Association or the Paint Horse Association.

DISCLAIMER

The stallion owner and the breeding station assume no liability for the shipment of semen. No compensation can be claimed from the stallion owner.

ADDITIONAL INFORMATION

No Give-Aways are included in the breeding fee. The stallion owners assume, that the foals will be registered online. A registration application on paper must therefore be specifically requested by the breeder.

GENERAL CONDITIONS

Information not in written form is not valid. With his/her signature the mare owner accepts the conditions in this contract. The contract is valid upon signing by the mare owner and the stallion owner. Please send the contract to the stallion owner by email or mail and include a copy of the mares' registration certificate.
