Mare owner and stallion owner hereby agree as follows :

1. BREEDING FACTS

Stallion owner hereby sells, and mare owner purchases a breed during the 2026 breeding season to the following stallion :

This fee is due and payable at the signature of this agreement and before semen will be shipped.

2. FRESH SEMEN

It will be available in the time period of

Fresh semen orders can be placed Monday-Friday until 10:00 a.m. (for international shipments before 09:00 a.m.) for same day collection and shipment.

The orders for fresh semen are limited to 2 orders within one cycle.

The mare(s) owner takes the expenses for collection, handling and shipping.

In case the stallion is not available due to illness or competition, the stallion owner has the right to offer only frozen semen for this period of time.

Competition dates will be published weeks up front.

A pay back of the breeding fee is not possible in any of the above mentioned cases.

3. FROZEN SEMEN

The frozen semen collection fee is included in the breeding fee.

All charges in relation to the A.I. Center are for the account of the mare(s) owner.

The shipment includes 2 doses of frozen semen (2 cycles).

Each insemination requires 8 straws (= 1 dose).

If more than 2 doses are necessary, a fee of € 200 per 2 doses must be paid.

4. REBREED

The rebreed of the mare that failed to receive is possible in the following year only.

The rebreed fee is 350€.

Expenses for collection, handling and shipping are the expense of mare owner.

Mare(s) owner receives another 2 doses after payment.

5. SHIPPING

All shipping expenses and importation fees are the responsibility of the mare(s) owner.

Stallion owner declines all responsibility for any accident that could happen during the transportation of the semen.

6. Life foal guarantee/Rebreed privileges shall apply only to the next breeding season. If the mare miscarries, aborts her foal, or fails to produce a single foal that can stand up unassisted, stallion owner will allow mare owner re-breeding privilege of the mare to stallion (or a substitute mare if acceptable to the stallion owner). Provided that the mare owner furnishes a veterinarian's statement by a licensed veterinarian attesting to either occurrence within 30 days of the date of the occurrence.

7. Stallion owner reserves the right to withhold issuance of a Breeders Certificate applicable to the breeding until mare owner is current on all payment obligations to stallion owner or/and veterinarian. In the event of multiple embryos, from single or subsequent flushes, the mare(s) owner will be liable for another breeding fee for each successful embryo transfer and resulting foals, payable when the recipient mare is checked in foal at 30 days with heartbeat.

8. Pregnancy losses or confirmations should be reported to the stallion owner before the end of October in the year of breeding.

9. Mare(s) owner agrees to return shipping container to stallion owner at mare owner expense within two weeks from the date of receiving the container.
