TERMS AND CONDITIONS

1. Royal Vista Ranch LLC (Royal Vista) Royal Vista hereby reserves for the Mare Owner one breeding to the Stallion named above during the Breeding Season. This reservation has been secured by the Mare Owner's payment of a Booking Fee, which is non-refundable and shall be applied to the Stallion Service Fee and included with this contract. If more than one pregnancy is desired from this Stallion (through embryo transfer), a Contract and Stallion Service Fee will be required for each breeding. If more than one embryo is produced and multiple embryos are transferred/vitrified, then the Mare Owner must notify Royal Vista within 48 hours of transfer/vit and immediately enter into an additional Contract(s) and pay the required Stallion Service Fee, which is due immediately. All contracts require a \$750 non-refundable booking fee, regardless of whether it is through a service auction, donated, or reduced breeding agreement. In the case that ICSI is performed and additional embryos are transferred, the full stud fee will be due when the Recipient Mare(s) reaches 45 days of pregnancy. For additional embryos vitrified, the mare owner must pay a \$750 non-refundable booking fee on each embryo at the time of vitrification. The balance of the current Stallion Service Fee can be paid on each embryo at the time of vitrification, OR the balance of the current year's Stallion Service Fee in the year of transfer can be paid when the Recipient mare reaches 45 days of pregnancy. *Please initial:* _____
ICSI will ONLY be available at GeneTech USA, Purcell, OK and Reliance In Vitro, Edmond, OK. *Please Initial:* _____
 Payments are to be made payable to Royal Vista Ranch.

2. Mare Owner The Mare Owner represents the Mare is healthy and in sound breeding condition and registered with the designated registration organization. The Mare Owner agrees to attach a copy of the Mare's registration papers with this document and agrees to furnish any other information as Royal Vista reasonably requests. The Mare must be managed by a veterinarian qualified in equine reproduction. Mare Owner agrees to use all semen provided by this Contract for ONLY the Mare named in this Contract. If the Mare dies or is deemed unfit to breed during the breeding season, a substitute Mare, approved by Royal Vista Ranch may be bred without any additional breeding fee. The Mare Owner agrees to have the Mare checked by ultrasound no later than 17 days after insemination and to provide Royal Vista with written results from a licensed veterinarian.

3. Charges The Mare Owner and/or any individual executing this Agreement shall agree to pay the following:

- (a) **Booking Fee** (due with the signing of this contract): \$ 750
- (b) **Balance of Stallion Service Fee**

4. Shipped Semen or Onsite Breeding and Fees Please mark the box for your selection:

- Shipped Semen** All fees must be paid in full prior to first shipment. *Fees subject to change.*
- (a) **Collection/Shipping Fee:** \$ 375 per collection (includes Priority Overnight shipping via FedEx)
 - (b) **Air Freight and Courier Charges** as incurred, should same day shipment be required by Mare Owner: \$ 475
 - (c) **Pick up at Royal Vista Ranch:** \$ 125
 - (d) **Frozen Semen Shipping Fee:** \$ 450 per shipment (includes Priority Overnight shipping via FedEx)
 - (e) **Canadian Shipping Fees:** Cooled/Fresh \$ 500 plus USDA fees Frozen semen \$ 600 plus USDA fees
 - (f) **Equitainer Deposit** will be waived. Mare Owner agrees to return the container at Mare Owner's expense, via FedEx, UPS, or USPS. Penalties of \$25 per day will apply for any Equitainer, Shipping Box or Dry Shipper not returned by the 5th day post-shipment. In the event that the equitainer/box becomes damaged, is missing contents, lost or not returned, Mare Owner agrees to pay a \$350 replacement fee. Replacement fee for the dry shipper is \$1200.
 - (g) **Shipment** The use of cooled or frozen semen has no warranty or guarantee, expressed or implied. No guarantee of delivery within a certain time period, nor the quality of the semen at arrival is given. In the event of insufficient semen on a particular breeding day Royal Vista reserves the right to determine which mares will be bred, based on reproductive status and order of request. Semen orders MUST be placed one day prior to shipment date. Confirmation or cancellation of the order must be done by **8:00am CST** the day of the collection to avoid late fees. A shipment may be canceled by **8:00am CST** without incurring a collection fee penalty. Mare Owner agrees to pay for shipments canceled following preparation and/or shipment. **STALLIONS ARE COLLECTED FEBRUARY 2 THROUGH JUNE 29, 2026 on MONDAYS, WEDNESDAYS AND FRIDAYS ONLY.** If the stallion is not available for cooled semen, frozen semen may be available with at least 24 hours advance notice at Royal Vista's discretion.
Royal Vista shall not be responsible for costs arising from shipments lost, damaged, or delayed in transit, or condition of cooled or frozen shipped semen upon delivery. We have no control of the shipment after it leaves our custody. Mare owner is responsible for all shipping fees.
 - (h) The Mare Owner agrees to use the semen shipped here-under solely to breed the designated Mare in accordance with this Breeding Contract together with the rules and regulations of the registration organization.

- Onsite Breeding** *Fees subject to change.*
- (a) **Board Rates:** \$24 /day Dry Mare \$27 /day Foal Watch or Wet Mare \$38 /day Preferred Care
 - (b) **Foaling Out** (if applicable): \$500
 - (c) **Reproductive Services:** \$250 per cycle (if carrying)
 - (d) **All other procedures and treatments.**
 - (e) If JL Dash Ta Heaven is not available for collection, frozen semen may be available.
 Additional breeding management fees will be associated with the use of frozen semen.
 1st cycle \$550 Additional cycles \$350 each

(f) All expenses (board, vet, farrier, etc.) are due monthly upon receipt of invoice. Balances over 30 days delinquent will be assessed a 1.5% service fee. The Mare will not be released until such time as the Stallion Service Fee, all veterinary expenses, board bill, and any other charges incurred on behalf of the Mare have been paid to Royal Vista in full.

5. **Live Foal Guarantee** This contract between the Mare Owner and Royal Vista for the above-named mare is non-transferable and provides for **one return breeding, in succeeding year only**, for the Mare (or agreed upon substitute) that fails to produce a live foal (newborn foal that stands and nurses without assistance). **Live Foal Guarantee is not applicable in a rebreed year.** Rebreed services will be provided under the following conditions:
- (a) Mare Owner provided Royal Vista with written confirmation from a licensed veterinarian of ultrasound results confirming pregnancy within 17 days of breeding.
 - (b) In the case of a miscarriage, stillborn foal, or death of mare after having been pronounced in foal, Mare Owner will provide Royal Vista with a written confirmation from a licensed veterinarian stating the cause of death, within 7 days.
 - (c) Rebreed services may be satisfied at the sole discretion of Royal Vista by 1) shipping semen, or 2) breeding onsite to be performed at Royal Vista Ranch.
 - (d) Mare owner may NOT assign, transfer, sell or substitute another mare under this Contract without prior written consent of Royal Vista. Any attempted assignment, transfer, sale or substitution without the prior consent of Royal Vista will, at the option of Royal Vista, terminate this Contract and release Royal Vista and the Stallion Owner from all obligations pertaining to this Contract.
 - (e) Rebreeding services apply only during the designated dates for breeding in the calendar year following the initial Breeding Season. Designation of these dates shall be at the sole discretion of Royal Vista and the Stallion Owner.
 - (f) **This contract carries a One Year Right of Return ONLY. Live Foal Guarantee is not applicable in a rebreed year.** _____ *please initial*

If the Mare Owner fails to rebreed the Mare the following year, then any and all fees become forfeited, the right to rebreed is cancelled and Royal Vista and the Stallion Owner are released from all further obligation of this contract, unless otherwise agreed upon in writing and signed by both parties.

6. **Breeder's Certificate** A Breeder's Certificate shall be issued when all fees have been paid in full, the Mare Owner notifies Royal Vista of the birth of a Live Foal and requests the Certificate. **Documents needed for registration will be withheld until all account balances are paid in full.**
7. **General** It is further agreed that should the stallion die, or become unfit for service prior to settling the mare, frozen semen will be utilized to fulfill contracts that have been paid in full. There shall be no cash refunds under this Contract. This Contract is not assignable, cannot be sold or gifted to anyone else, and is transferable only as stated above and with written consent of both Mare Owner and Royal Vista.
8. **Other Provisions** When Mare Owner, or authorized representative, signs and returns this contract to Royal Vista, it will be a binding contract on both parties, subject to the above terms and conditions. This contract is not transferrable or assignable. The Mare Owner/Lessee agrees that interest of 1.5% will be charged on all accounts that are 30 days past due. The Mare Owner/Lessee agrees to pay all reasonable collection and attorney fees incurred by Royal Vista in attempting to collect any outstanding balance. The Mare Owner/Lessee acknowledges the lien rights of Royal Vista Ranch LLC pursuant to state law (T4 O.S. Chapter 6, Sections 191 through 201 and any amendments or additions thereto).
